1. ACCEPTANCE OF TERMS

By creating an account, accessing, or using Dropfans.io ("the Platform"), you agree to be bound by these Terms of Service. If you do not agree, you may not use the Platform.

2. ELIGIBILITY AND AGE RESTRICTION

2.1. Strict 18+ Requirement: You must be at least 18 years of age (or the age of majority in your jurisdiction) to access this Platform. **2.2. Verification:** You agree to provide valid government-issued identification upon request to verify your age and identity. Failure to provide this will result in immediate account termination. **2.3. Prohibited Jurisdictions:** You may not use the Platform if you are located in a jurisdiction where access to adult content is prohibited by law.

3. USER ACCOUNTS

3.1. Account Security: You are responsible for maintaining the confidentiality of your login credentials. **3.2. One Account Per Person:** Users are prohibited from creating multiple accounts to evade bans or manipulation limits. **3.3. Accurate Information:** You agree to provide accurate, current, and complete information during the registration and KYC (Know Your Customer) process.

4. CONTENT CREATOR POLICY (MODELS)

4.1. Identity Verification: All Creators must undergo biometric identity verification (KYC) before uploading content. **4.2. Consent & 2257 Compliance:**

- You confirm that all individuals appearing in your content are 18+ and have consented to the distribution of the content on this Platform.
- **Multi-Person Content:** If content features additional participants, they must also undergo independent KYC verification and sign a Model Release through our system prior to publication. **4.3. Record Retention:** We retain all 2257 exemption records and identity documents for a minimum of 7 years in compliance with federal and international laws.

5. PROHIBITED CONTENT

The following content is **strictly prohibited**. Uploading such content will result in an immediate permanent ban and reporting to relevant authorities (e.g., NCMEC):

- Child Sexual Abuse Material (CSAM) or any depiction of minors.
- Non-consensual content ("revenge porn") or content taken without the subject's knowledge.
- Bestiality, violence, rape simulations, or illegal acts.

- **Deepfakes/Celebrity AI:** AI-generated content depicting real people (celebrities, public figures, or private individuals) without their explicit written consent is strictly prohibited.

6. AI CONTENT POLICY

6.1. Disclosure: Creators must disclose if content is AI-generated. **6.2. Restrictions:** AI content must not simulate non-consensual scenarios or depict real individuals (deepfakes). The Platform utilizes automated scanning tools to detect and remove unauthorized likenesses.

7. FINANCIAL TERMS

7.1. Fees: The Platform charges a commission fee on transactions, which is deducted automatically before payout. **7.2. Refunds:** All purchases are final. Refunds are only granted at the sole discretion of the Platform (e.g., in cases of technical failure). **7.3. Chargeback Policy:**

- We have a **Zero Tolerance** policy for chargebacks.
- If you issue a chargeback without contacting support first, your account will be permanently banned, and your details may be shared with credit risk databases.
